Title I, Canon 3, Section 7:

“The Secretary, Treasurer, Chancellor, the Vice Chancellors, the Chair of the Committee on Constitution and Canons, the Registrar, the Lay Members of the Bishop and Council and the Standing Committee, three youth representatives of the Youth Action Council, the President of the Episcopal Endowment Corporation, the Vice Chancellor, the Dean of the School of Theology, and the Chaplain of the University of the South, the Headmaster of St. Andrew's-Sewanee School, and the President of each Area Commission which has been organized pursuant to Title III Canon 4, if not members of the Convention by virtue of being either a member of the Clergy canonically resident or a Lay Delegate representing a Parish of the Diocese, shall be ex-officio, admitted to seats upon the floor of the Convention, with all privileges except the right to vote.”

Subsequent information will be sent *only* to those who have registered. This mailing will be sent by e-mail to the addresses we receive, otherwise by regular mail. Copies of the mailing will be available on the diocesan web site (www.etdiocese.net).
