

SOCIAL MINISTRIES GRANT

Policy and Procedures

Statement of Purpose and Policy

Social ministries grants are funded to assist parishes and missions within the Diocese of East Tennessee that seek to support ministries that meet basic human needs (food, shelter, and energy, as well as emotional, educational and spiritual) and those ministries that seek to affect personal and/or societal transformation through education, rehabilitation and allocation of resources according to the mission and ministry of the Church. Ministries may be separate entities but must have significant Episcopal Church involvement and must be approved by Vestry/Council/Board of Directors of Diocesan organization.

An Opportunity Fund Committee shall be appointed by the Bishop to receive all grant applications and to make recommendations to the Bishop and Council. All Opportunity Fund Social Ministry Grants are subject to approval by the Bishop and Council.

No annual grant shall be repeated for more than three consecutive years.

Procedures for Application

Applications for grants are to be made in writing on forms available through the Diocesan Office. They may be initiated by the Bishop and Council, a parish, a mission, or a diocesan area commission of the Diocese. Clergy may make application through the afore said bodies.

Completed application forms are returned to the Diocesan Center.

The grants committee chairperson will designate a committee member to review each application. The grant applicant will be contacted if further information is necessary.

Grants are reviewed twice a year. Deadlines for submitting grants are **April 1 and September 1.**

Grant recommendations are presented to Bishop and Council for approval following committee review.

Applicants are notified by mail of acceptance or denial of their applications. Grant recipients are accountable for the Opportunity Fund monies. Evaluation forms will be sent and are to be returned within one year from the date the grant was awarded.
